
Ticks

Roundworms

1 in 4 UK cats are shedding roundworm eggs⁴. A cat's lifestyle can expose them to risk of mixed infection; therefore, approximately 68% of UK cats have a relevant risk factor that makes monthly deworming necessary¹. Quarterly worming gives the opportunity for Toxocara spp. to reach patent infection and shed more eggs.



Hunting and grooming both put cats at risk from tapeworm infection, and most cases get missed in routine faecal tests⁷. NexGard® COMBO is the only monthly treatment that also covers tapeworms. Tapeworms are zoonotic and are therefore also a risk to humans.
