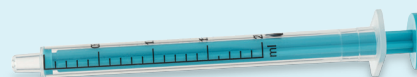

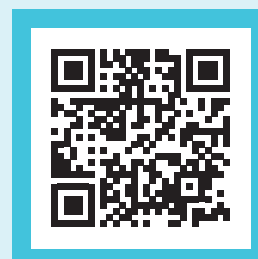

‡Dosing guidelines: when treating concomitant CKD and HT, dose according to the HT dose. After 4 weeks, the dosage of telmisartan may be reduced in cats with systolic blood pressure (SBP) of less than 140 mmHg (in 0.5 mg/kg increments) at the discretion of the veterinary surgeon. If SBP increases over the course of the disease, the daily dose may be increased again up to 2 mg/kg. Target SBP range is between 120 and 140 mmHg. The recommended minimum effective dose when treating concomitant CKD and HT is 1 mg/kg
